## WEATHERING THE STORM

The widening economic gap in our city must not widen the educational gap. At Perspectives, we're relentless in ensuring that doesn't happen for our students, and it shows. We recently earned all Level 1 and 1+ schools across our entire network. To achieve a Level 1 rating for a single school is a great achievement, to receive this across the board is truly unique and positions us as an elite charter network in Chicago.

We live in a state with the most backwards education funding model in the nation. This leads to vast resource gaps in public schools, which impacts our ability to serve our students at Perspectives.

Last year, we experienced a mid-year budget cut of 4 percent, and then faced an additional 11 percent cut when the state failed to pass a budget for the second year in a row. Imagine what those cuts have meant for Chicago's students, teachers, classrooms, and schools. These injustices towards students have exacerbated the gap between haves and have-nots.

In the face of last year's draconian cuts, we redoubled our commitment to provide a high-quality education. We improved academic success, and then grew our offerings far beyond classroom learning. We maintained over 100 free after-school programs, offered enrollment in post-secondary classes providing students with college credits, and continued to offer Adobe professional certification in our High School of Technology. Those are just a few examples.

We did not do this alone. We benefited from stable partnerships with individuals and companies who are relentless as well: they believe as we do in our students' potential. We're proud to highlight our partnerships with New Schools For Chicago, Invest For Kids, Akuna Capital, and our decade-long partnership with EY.

Our landscape challenges us but our relationships encourage us. In our collaboration, our relentlessness multiplies and so does our impact.






## **GPA GROWTH WITH AFTER SCHOOL PROGRAMMING**




