RESOLUTION OF THE BOARD OF DIRECTORS OF PERSPECTIVES CHARTER SCHOOLS

WHEREAS, Anthony Anderson has served in a leadership role and on Perspectives Charter Schools' Board of Directors for the last fifteen years, including as Perspectives Charter Schools' Chairman of the Board of Directors and Executive Committee of the Board of Directors;

WHEREAS, the Board of Directors, students and staff at Perspectives would like to recognize Tony for his outstanding service and for modeling our 26 Principles of A Disciplined Life;

WHEREAS, Fifteen years ago, Tony and his team at EY made a decision to give time, talent and financial support to Perspectives. Since that time, hundreds of students have been impacted by our EY partnership. Because of Tony's leadership, Perspectives students have been given the opportunity to experience career and academic mentoring through the College Map Program, holiday giving drives, college scholarship funds, community service, etiquette classes, job interview coaching, and so much more. This corporate-public school model serves as a model for others.

WHEREAS the Board of Directors and Perspectives Charter Schools staff and students want to thank Tony for being a member of the Perspectives family and for 15 years of dedicated service as a leader and Perspectives board member and Chairman, which involved so many significant accomplishments, including, but not limited to:

- Successful Future Growth Fund Campaign that raised \$5 million in three years that secured and transitioned our Auburn Gresham campus to the state of the art Perspectives Leadership Campus which welcomed 800 students last fall
- Successful integration of the Young Women's STEM Leadership Program at Perspectives/IIT Math & Science Academy allowing female students to thrive in STEM subjects
- Successful annual Gala growth helping us to increase our fundraising from \$500 thousand to \$1 million every spring and develop partnerships that have allowed our network to explore new programmatic and operational funding opportunities.
